I. INTRODUCTION

A. Purpose and Intent.

This Amended and Restated Service Plan, submitted in accordance with the Special District Act (Section 32-1-101, *et seq.*, C.R.S.) and Jefferson County Policies and Procedures (Jefferson County Policies and Procedures Manual, Part 7, Chapter 2, § 5), sets forth a proposal for amending and restating the Service Plan for the Plains Metropolitan District (the "District"), dated April, 1985.

This Service Plan consists of a preliminary financial analysis and preliminary engineering survey showing how public improvements and services may be provided and financed by the District. Numerous items were included in this Service Plan in order to satisfy the requirements of law for formation of special districts and the requirements of Jefferson County. Each of the requirements of law and of the County is satisfied by this Service Plan.

The assumptions contained within this Service Plan were derived from a variety of sources. Legal advice in the preparation of this Service Plan was provided by Spencer Fane LLP. Financial recommendations and advice in the preparation of the Service Plan were provided by Simmons & Wheeler PC, the District's accountant and Dave Peak, the District's manager.

B. Need for the District.

There are currently no other governmental entities, including the County, located in the immediate vicinity of the District that consider it desirable, feasible, or practicable to undertake the planning, design, acquisition, construction, installation, relocation, redevelopment, financing, and ongoing operations of the public improvements needed for the property in the District. A vicinity map and list of municipalities and special districts in the vicinity of the District are attached as Exhibit A. An amendment to the Service Plan is, therefore, necessary in order to provide the Public Improvements and services required now and in the future for the property within the District in the most economic manner possible.

C. District Functions Generally.

The District shall be authorized, but not obligated, to fund the Public Improvements from the proceeds of Debt to be issued by the District and from other legally available revenue. It is expected that some of the Public Improvements will be dedicated to the County or other service provider in accordance with the County's or such service provider's applicable policies and procedures. For any improvements that are not conveyed to the County or other appropriate service provider, the District shall be authorized, but not obligated, to own, operate and maintain such Public Improvements from any legally available revenues of the District.

Construction of all Public Improvements shall be subject to applicable ordinances, codes, and regulations of the County and pursuant to the requirements of any Approved

Development Plan, as well as the applicable ordinances, codes, and regulations of any other governmental entity having proper jurisdiction over the Public Improvements.

II. DEFINITIONS

In this Service Plan, the following terms shall have the meanings indicated below, unless the context hereof clearly requires otherwise:

Approved Development Plan: means an approved final development plan or other process established by the County or other governmental entity with jurisdiction over the Public Improvements that sets forth the requirements and timing associated with construction of the Public Improvements, as may be amended from time to time.

Board: means the board of directors of the Plains Metropolitan District.

Board of County Commissioners: means the Board of County Commissioners of Jefferson County, Colorado.

County: means Jefferson County, Colorado.

Debt: means bonds, notes, or other obligations for the payment of which the District has promised to impose a multiple fiscal year *ad valorem* property tax mill levy.

District: means the Plains Metropolitan District, a quasi-municipal corporation and political subdivision of the State of Colorado organized pursuant to Article 1 of Title 32, Colorado Revised Statutes.

District Activities: means any and all functions undertaken by the District in accordance with this Service Plan and as permitted under applicable law in order to effectuate the purposes for which the District is organized.

District Boundary: means the boundary of the District as described in Exhibit B.

District Boundary Map: means the map attached hereto as Exhibit C, depicting the District's boundary.

Fee(s): means any rate, fee, toll, penalty or other charge imposed by the District and permitted by applicable law for services, programs, improvements, or facilities provided by the District.

Financial Plan: means the Financial Plan of the District as described in Section VI, which describes (i) how the Public Improvements may be financed; (ii) how Debt may be incurred; (iii) the estimated operating revenue derived from property taxes for the current budget year; and (iv) the proposed sources of revenue and projected expenses of the District.

Maximum Debt Mill Levy: means the maximum mill levy the District is permitted to impose for payment of Debt as set forth in Section VI.C. below.

Maximum Net Effective Interest Rate: means the maximum net effective interest rate applicable to the issuance of any Debt, which is ten percent (10%) under this Service Plan.

Maximum Operations Mill Levy: means the maximum mill levy the District is permitted to impose for payment of operations and maintenance costs as set forth in Section VI.G. below.

Maximum Underwriting Discount: means the maximum underwriter's discount applicable to any issuance of Debt, which is three percent (3%) under this Service Plan.

Preliminary Engineering Survey: means the description set forth in Section V.C.

Public Improvements: means a part or all of the improvements authorized to be planned, designed, acquired, constructed, installed, relocated, redeveloped, extended, operated, maintained, and/or financed, including necessary and appropriate landscaping and appurtenances, as generally described in the Preliminary Engineering Survey and Section V.D., below, to serve the taxpayers and inhabitants of the Service Area and the public as determined by the Board.

Service Area: means the property within the District Boundary Map, as modified by any future inclusions or exclusions of property.

Service Plan: means this service plan for the District approved by the Board of County Commissioners, as may be amended from time to time.

Service Plan Amendment: means an amendment to the Service Plan approved by the Board of County Commissioners in accordance with the County's policies and the applicable state law.

Special District Act: means Section 32-1-101, *et seq.*, of the Colorado Revised Statutes, as amended from time to time.

State: means the State of Colorado.

TABOR: means Article X, Section 20 of the Colorado Constitution.

Taxable Property: means real and personal property within the Service Area subject to *ad valorem* taxes imposed by the District.

III. DISTRICT BOUNDARY

A. Legal Description.

The area of the District Boundary includes approximately 490 acres. A legal description of the District Boundary is attached hereto as Exhibit B. A map depicting the District Boundary is attached hereto as Exhibit C.

The District's boundary may change from time to time as it undergoes inclusions and exclusions pursuant to Section 32-1-401, *et seq.*, C.R.S., and Sections 32-1-501, *et seq.*, C.R.S., but no such changes are anticipated at this time.

B. Ownership.

A complete list of residents and owners of real property within the District Boundary is as attached as Exhibit D.

IV. PROPOSED LAND USE AND ASSESSED VALUATION

The Service Area consists of approximately 490 acres: 64 acres are zoned for commercial uses; 119 acres for office/industrial uses; 114 acres for open space; 80 acres zoned for single-family units; 24 acres zoned for townhome units; 45 acres zoned for multi-family units; and 44 acres for infrastructure (roads, etc.). Approximately 302 acres have already been developed. At build out, it is anticipated that the District will contain 1,804 residential units. The current assessed valuation of the Service Area is \$83,199,836 and, at build out, the assessed valuation is expected to be sufficient to reasonably discharge any Debt issued under the Financial Plan. The population of the Service Area is currently estimated to be 4,390 persons at buildout, based on an average of 2.4 persons per residential unit and 1,804 total units

Approval of this Service Plan by the County does not imply approval of the development of a specific area within the Service Area of the District, nor does it imply approval of the number of residential units identified in this Service Plan or any of the exhibits attached thereto, unless the same is contained within an Approved Development Plan.

V. DESCRIPTION OF PROPOSED POWERS, IMPROVEMENTS AND SERVICES

A. Powers of the District and Service Plan Amendment.

The District shall have the power and authority, but not the obligation, to provide the Public Improvements and undertake related District Activities within and without the Service Area of the District as such power and authority is described in the Special District Act, and other applicable statutes, the common law, and the State Constitution, subject to the limitations set forth in this Service Plan. Further, the District shall have the power, but not the obligation, to provide any and all services necessary or incidental to the provision of the Public Improvements. The specific types of Public Improvements shall be determined in the sole discretion of the Board and may include those Public Improvements as generally described in Section V.D.

B. Limitations on the District's Powers and Service Plan Amendment

1. Operations and Maintenance Limitation. The District shall dedicate certain Public Improvements to the County or other appropriate service providers in a manner consistent with the Approved Development Plan and/or other policies, procedures and rules and regulations of the County or other applicable service providers. The District shall be authorized, but not obligated, to own, operate, and maintain any part or all of the Public Improvements not otherwise dedicated to another entity.

Determination of specific Public Improvements to be dedicated or to be retained by the District may be the subject of separate agreements among the interested parties.

2. Construction Standards Limitation. The District will ensure that the Public Improvements to be dedicated or maintained by the District are designed and constructed in accordance with the standards and specifications of the County, as well as the applicable standards of other governmental entities having jurisdiction over the specific Public Improvements. The District will obtain approval of civil engineering plans and will obtain applicable permits for construction and installation of Public Improvements from the County or other governmental entity with jurisdiction, as appropriate, and prior to performing such work.

3. Total Debt Issuance Limitation. The District shall not issue Debt in excess of Ten Million Dollars (\$10,000,000). Increases necessary to accomplish a refunding, reissuance or restructuring of Debt shall not count against the Total Debt Issuance Limitation if a present value savings may be demonstrated.

4. Service Plan Amendment Requirement. Actions of the District that constitute material modifications to this Service Plan under the Special District Act shall entitle the County to all remedies available under State and local law to enjoin such actions, or the District shall obtain a service plan amendment, as required by § 32-1-207, C.R.S.

5. Ken Caryl Ranch Water and Sanitation District. The District hereby acknowledges that, with the exception of irrigation services ancillary to the District's construction, operation and maintenance of streetscape and open spaces related to storm drainage detention and mitigation, Ken Caryl Ranch Water and Sanitation District will be the sole provider of water and sanitary sewer services within the Service Area of the District.

C. Preliminary Engineering Survey

The District will have the authority, but not the obligation, to provide and/or acquire those facilities generally described below in Section V.D. The actual design, phasing location and completion of the Public Improvements will be determined by the District in its sole discretion, to coincide with the development in the District, the availability of funding sources and subject to receipt of all necessary approval of any governing jurisdiction. An estimate of the costs associated with the Public Improvements is shown in Exhibit E.

D. Proposed Public Improvements and District Services.

The District will be permitted to exercise its statutory powers and authority as set forth herein to finance, construct, acquire, operate and maintain the public facilities and improvements described in this Service Plan either directly or by contract. Where appropriate, the District will contract with various public and/or private entities to undertake such functions. Construction of all Public Improvements will be scheduled to allow for proper sizing and phasing to keep pace with need.

The following is a general list of the Public Improvements that may be constructed by the District. Because the District may, under this Service Plan, expand or contract its improvement construction plans and services provided, this list is not intended to be exhaustive nor concrete.

1. Storm Sewer. The District shall have the power, but not the obligation, to provide for the financing, acquisition, construction, completion and installation of storm sewer, flood and surface drainage facilities and systems, including detention/retention ponds and associated irrigation facilities, and all necessary, incidental, and appurtenant facilities, land and easements, together with extensions of and improvements to said system within and without the boundaries of the District.

2. Street Improvements. The District shall have the power, but not the obligation, to provide for the financing, acquisition, construction, completion, installation and/or operation and maintenance of street improvements, both on-site and off-site, including curbs, gutters, culverts, sidewalks, bridges, overpasses, bike paths and pedestrian ways, interchanges, median islands, paving, grading, irrigation, streetscape and entryways, landscaping, parking lots and structures, together with all necessary, incidental, and appurtenant facilities, land and easements, together with extensions of and improvements to said facilities within and without the boundaries of the District. Following completion, the streets within the District are intended be dedicated to the County for ownership, operation and maintenance, while ownership, and the operation and maintenance responsibility, for certain other roads is anticipated to be retained by the District. It is anticipated that streetscaping improvements may be maintained by the District or transferred to another appropriate entity.

The following street improvements were described in the original service plan and have been completed and dedicated to the County: widening of Ken-Caryl Avenue west of Simms Street; acceleration and deceleration lanes on Ken-Caryl Avenue and Chatfield Avenue; Shaffer Parkway; Alkire Place; a portion of Alkire Street; and alterations to the Alkire/Ken-Caryl Avenue and Chatfield-Simms/Ken-Caryl Avenue intersections.

3. Safety Protection Improvements. The District shall have the power, but not the obligation, to provide for the financing, acquisition, construction, completion, installation and/or operation and maintenance of facilities and/or services for a system of traffic and safety controls and devices on streets and highways, including, but not limited to, signalization, signage and striping, area identification, driver information and directional assistance signs, lighting, entry monumentation and all necessary, incidental and appurtenant facilities, land and easements, together with extensions of and improvements to said facilities within and without the boundaries of the Service Area. All safety protection improvements are intended to be conveyed to the proper entity for perpetual ownership, operation and maintenance.

4. Park and Recreation. The District shall have the power, but not the obligation, to provide for the design, acquisition, construction, financing, completion, installation and/or operation and maintenance of parks and recreational facilities and programs, including, but not limited to, parks, bike paths and pedestrian ways, open space, landscaping, cultural activities,

water bodies, irrigation facilities, and other active and passive recreational facilities and programs, and all necessary, incidental and appurtenant facilities, land and easements, together with extensions of and improvements to said facilities within and without the Service Area. It is currently anticipated that certain park and recreation improvements may be retained, operated and maintained by the District, while others will be dedicated to and operated and maintained by an owners association or other appropriate entity.

5. Other Powers. In addition to the enumerated powers, the Board shall also have the following authority:

(a) Service Plan Amendments. To amend the Service Plan as needed, subject to the appropriate statutory procedures.

(b) Phasing, Deferral. Without amending this Service Plan, to defer, forego, reschedule, or restructure the financing and construction of certain improvements and facilities, to better accommodate the actual pace of growth, resource availability, and potential inclusions and exclusions of property within the District.

VI. FINANCIAL PLAN

A. General.

The District shall be authorized, but not obligated, to provide for the planning, design, acquisition, construction, installation, relocation and/or redevelopment of the Public Improvements from its revenues and by and through the proceeds of Debt issued by the District. Before issuing debt the District will hold an election to get approval from its electorate. The Financial Plan for the District will be to issue such Debt as development occurs such that the District can reasonably pay from revenues derived from the Maximum Debt Mill Levy and other legally available revenues. Once voter authorization is obtained, the total Debt that the District shall be permitted to issue shall not exceed Ten Million Dollars (\$10,000,000) and shall be permitted to be issued on a schedule and in such year or years as the District determines shall, in its sole discretion meet the needs of the Financial Plan and phased to serve development as it occurs. All Debt issued by the District may be payable from any and all legally available revenues of the District, including general *ad valorem* taxes and Fees to be imposed upon all Taxable Property within the District, as the Board of Directors may deem appropriate. The District may also rely upon various other revenue sources authorized by law. A financial analysis showing the District's budget forecast and an example of a possible bond issuance is attached hereto as Exhibit F.

The amount of bonds issued, the mill levy pledged, the date of issuance, the term of the bonds and the other information in the Financial Plan is intended to show the District's ability to issue and repay debt. The actual bond issues by the District will differ from the example. None the less, all issuances of bonds shall be deemed to be in compliance with the Financial Plan so long as the Minimum Criteria, as hereinafter defined, have been met. Minimum Criteria shall mean that the bonds are: (1) subject to a limited mill levy, if required by this Service Plan; (2) together with other outstanding general obligation bonds, not in excess of

the Total Debt Issuance Limitation set forth in this Service Plan, as may be amended from time to time; and (3) together with other outstanding bonds, not in excess of the Debt authority approved by the District's electorate.

B. Maximum Net Effective Interest Rate and Maximum Underwriting Discount.

The interest rate on any Debt is expected to be the market rate at the time the Debt is issued, but in no event shall the interest rate on any Debt issued by the District exceed the Maximum Net Effective Interest Rate. The underwriting discount on any Debt shall not exceed the Maximum Underwriting Discount. Debt, when issued, will comply with all relevant requirements of this Service Plan, State law and Federal law as then-applicable to the issuance of public securities.

C. Maximum Debt Mill Levy.

The Maximum Debt Mill Levy shall be the maximum mill levy the District is permitted to impose upon the Taxable Property within the District for payment of Debt, and shall be determined as follows:

1. The Maximum Debt Mill Levy for Debt shall be Ten (10) mills; provided that if after January 1, 2018 there are changes in the method of calculating assessed valuation or any constitutionally-mandated tax credit, cut or abatement, the mill levy limitation applicable to Debt may be increased or decreased to reflect such changes, such increases or decreases to be determined by the Board in good faith (such determination to be binding and final) so that to the extent possible, the actual tax revenues generated by the mill levy, as adjusted for changes occurring after January 1, 2018, are neither diminished nor enhanced as a result of such changes. For purposes of the foregoing, a change in the ratio of valuation for assessment of residential real property of other taxable property shall be deemed to be a change in the method of calculating assessed valuation.

D. Debt Repayment Sources.

The District may impose a mill levy on Taxable Property within its boundaries as a primary source of revenue for repayment of debt service and for funding District Activities. The District may also rely upon various other revenue sources authorized by law. At the District's discretion, these may include the power to assess Fees. In no event shall the debt service mill levy in the District exceed the Maximum Debt Mill Levy. Mill levies and Fees intended to fund general District Activities will be in direct relation to the cost of providing the services contemplated in this Service Plan.

E. Security for Debt.

The District shall not pledge any revenue or property of the County as security for the Debt authorized in this Service Plan. Approval of this Service Plan shall not be construed as a guarantee by the County of payment of any of the District's obligations; nor shall anything in the Service Plan be construed so as to create any responsibility or liability on the part of the County in the event of default by the District in the payment of any such obligation.

F. TABOR and Statutory Compliance.

1. The District will comply with the provisions of TABOR. In the discretion of the Board, the District may set up enterprises or other qualifying entities to manage, fund, construct and operate facilities, services, and programs. To the extent allowed by law, any entity created by the District will remain under the control of the Board.

2. All Debt issued by the District must be issued in compliance with the requirements of Section 32-1-1101, C.R.S., and all other requirements of State law.

G. District's Operating Costs.

The estimated cost of engineering services, legal services, administrative services, and operations, are anticipated to be Fifty Thousand Dollars (\$50,000).

In addition to the capital costs of the Public Improvements, the District will require operating funds for administration and to plan and cause the Public Improvements to be constructed and maintained. The operating budget, including legal and accounting expenses for 2018 is estimated to be Seven Hundred Seventy Two Thousand and Seventy One Dollars \$772,071, which is anticipated to be derived from property taxes and other revenues.

The Maximum Debt Mill Levy for the repayment of Debt shall not apply to the District's ability to increase its mill levy as necessary for provision of operation and maintenance services to its taxpayers and service users, however, the operations mill levy shall not exceed Eight (8) mills.

H. Overlapping Mill Levies.

The District is also located within several other political subdivisions as outlined on Exhibit G.

I. Financial Plan Flexibility.

The District's Financial Plan has some flexibility built into it in a number of ways. The list of Public Improvements provided in this Service Plan is only a list of what the District has authority to provide and the District will not be obligated to provide the Public Improvements. The Preliminary Engineering Survey is only an estimate of the cost of the Public Improvements. Financially, the District is not obligated to issue debt at any time and is not obligated to issue the maximum debt allowed under this Service Plan. Additionally, if debt is issued by the District, it may be issued in phases and in concurrence with the construction of Taxable Property so as to parallel the increasing assessed value of the District and need.

VII. DISCLOSURE AND ANNUAL REPORT

A. General.

If requested by the County, the District shall be responsible for submitting an annual report to the County no later than August 1st of each year following the year in which the Order and Decree creating the District has been issued.

B. Reporting of Significant Events.

The annual report shall include information as to any of the following:

1. Boundary changes made or proposed to the District's boundary as of December 31 of the prior year.
2. Intergovernmental Agreements with other governmental entities, either entered into or proposed as of December 31 of the prior year.
3. A summary of any litigation which involves the Public Improvements as of December 31 of the prior year.
4. Status of the District's construction of the Public Improvements as of December 31 of the prior year.
5. A list of all Public Improvements constructed by the District that have been dedicated to and accepted by the County as of December 31 of the prior year.
6. The assessed valuation of the District for the current year.
7. Current year budget including a description of the Public Improvements to be constructed in such year.
8. Notice of any uncured events of default by the District, which continue beyond a ninety (90) day period, under any Debt instrument.
9. Any inability of the District to pay its obligations as they come due, in accordance with the terms of such obligations, which continue beyond a ninety (90) day period.

IX. CONCLUSION

1. There is sufficient existing and projected need for organized service in the area to be serviced by the District;

3. The District is capable of providing economical and sufficient service to the area within its proposed boundaries;
4. The area to be included in the District does have, and will have, the financial ability to discharge the proposed indebtedness on a reasonable basis;
5. Adequate service is not, and will not be, available to the area through the County or other existing municipal or quasi-municipal corporations, including existing special districts, within a reasonable time and on a comparable basis;
6. The facility and service standards of the District are compatible with the facility and service standards of the County;

7. The proposal is in substantial compliance with a master plan adopted pursuant to § 30-28-106, C.R.S.;

8. The proposal is in compliance with any duly adopted County, regional or state long-range water quality management plan for the area; and

9. The creation of the District is in the best interests of the area proposed to be served.

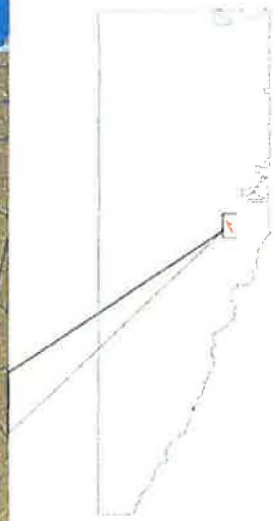
Map of District Boundary

Summary of Significant Assumptions and Accounting Policies December 31, 2018 through 2049

The foregoing forecast presents, to the best of the District's knowledge and belief, the expected cash receipts and disbursements for the forecast period. Accordingly, the forecast reflects its judgement as of June 5, 2018. The assumptions disclosed herein are those that the District believes are significant to the forecast. There will be differences between the projected and actual results, because events and circumstances frequently do not occur as expected, and those differences may be material.

This forecast is only an example of what may occur, and is meant to show the capacity of the District to issue debt. As such, the dates, mill levies, valuations, amount of the bond proceeds, revenues and expenditures may differ when debt is issued, and this forecast will not be binding on the District as long as the debt falls within the restrictions in the text of the District's service plan

The purpose of this forecast is to show the ability to repay a proposed bond issue in 2019 totaling \$13,000,000 from the imposition of a Debt Service Fund mill levy of 10.000 mills commencing in 2020.

Note 1: Ad Valorem Taxes

The primary source of revenue for the District will be the collection of ad valorem taxes. Residential property is forecasted to be assessed at 7.20% of market values. Commercial property is assessed at 29% of market values. The forecast assumes market values of property will not inflate over the life of the forecast.

Property is assumed to be assessed annually as of January 1st. The forecast recognizes the related property taxes as revenue in the subsequent year.

The County Treasurer currently charges a 1.5% fee for the collection of property taxes. These charges are reflected in the accompanying forecast as County Treasurer fees.

The mill levy imposed by the District are proposed to equal 8.00 mills for operations and 10.00 mills for debt service for a total levy of 18.00 mills.

The forecast assumes that Specific Ownership Taxes collected on motor vehicle registrations will be 6% of property taxes collected. It is projected that the percentage of the Specific Ownership Taxes attributable to the Debt Service mill levy will be pledged to the Series 2019 bonds and the percentage attributable to the General Fund mill levy will be used to pay for operating expenses.

Note 2: Bond Assumptions

The District proposes the issuance of general obligation bonds totaling \$13,000,000 on September 1, 2019. The bonds are projected to carry a coupon rate of 4.50% and mature 30 years from their issuance. It is anticipated that the bonds will be secured by a portion of the Specific Ownership Taxes attributable to the Debt Service Fund mill levy of 10.000 mills. Exhibit II reflects the proposed repayment schedule of these bonds. The following table reflects the proposed sources and uses of funds for the issues.

The proposed Series 2019 Bonds are estimated to provide \$12,331,750 of funds available for District improvements.

Note 4: Operating and Administrative Expenses

It is forecasted that the operating and administrative expenses in the amount of \$695,551 will continue to be funded from an operating mill levy of 8.000 mills as indicated in Exhibit I.
